MVP was directed by the FERC's third-party consultant to provide clarification regarding Mountain Valley Pipeline Project Variance MVP-FS-002 that was included in a letter report submitted to your office on October 16, 2018, in reference to *Access Road MVP-ANC-009-Variance and Workspace MVP-FS-002*. In that report, SEARCH indicated that Variance MVP-FS-002 would be a temporary workspace. As requested in your office's comment letter on that report, dated November 14, 2019 (15-67-Multi-135), MVP is notifying you that the workspace is proposed to be a permanent workspace for the storage of

rock. No permanent aboveground structures are proposed with this change, and no tree clearing is required. No cultural resources were documented within the proposed variance during previous survey. This workspace is surrounded by modern industrial and commercial buildings less than 50 years old, which do not meet the eligibility criteria for listing in the NRHP. The roadways surrounding this workspace location are actively maintained public roads and highways; due to this, the permanent use of this workspace will not have indirect visual impacts on the road. As such, we recommend permanent use of MVP-FS-002 will not cause adverse visual impacts on any NRHP-eligible or -listed aboveground historic resource.

Please don't hesitate to contact me if you need additional information. Because the nature of the workspace is changing from temporary to permanent, we request a formal comment and permission to proceed with MVP-FS-002 as a permanent workspace.
