The EI performed a SWPPP inspection from 14928+52 to 15063+85 (Ramsey Memorial Road to Armstrong Road). The contractor had an environmental crew foreman walk with the EI on his inspection. Three issues were submitted for the punch list including one location with damaged P1 silt fence, and one location where CFS around a plunge pool was damaged by wildlife, and one location where perimeter CFS was damaged by farm equipment. Other ECDs inspected were in compliance at the time of inspection.  Since the last SWPPP inspection the inspection area has received a single rain event of 1.30" of rain at both Indian Cave Road and Armstrong Road.  The ROW ground condition is mostly wet.  At the time of inspection temporary vegetative stabilization was sufficiently established to inhibit erosion.  At the time of inspection permanent vegetative stabilization was sufficiently established from 14960+00 to 14981+00. From 14988+00 to 14995+00 permanent vegetative stabilization has been established but the area has been grazed heavily by cattle resulting in diminished growth.
