The Department of Environmental Quality (DEQ) hereby approves the following modifications to the Combined Stormwater Management (SWM) and Erosion & Sediment Control (ESC) Plan:

- MVP-51, Typical Waterbody Conventional Bore, Sign/Seal Date 9/21/2022.
- MVP-17.8A, Temporary Travel Lane Crossing at Waterbar Slope  $\geq 30\%$  Condition, MVP-17.8 Temporary Water Bar Installation for Slopes  $\geq 30\%$ , Sign/Seal Date 12/12/2022.
- Centerline Shift MP 207.5, Erosion & Sediment Control Plans, Post Construction Stormwater & Restoration Plans, Sheet Number 13.06 ES and 13.06 PC, Sign/Seal Date 12/7/2022.

Additionally, approval of these modifications does not relieve the owner and/or operator of complying with all other federal, state, or local laws and regulations. As provided by Rule 2A:2 of the Supreme Court of Virginia, you have thirty (30) days from the date you received this decision within which to appeal this decision by filing a notice of appeal in accordance with the Rules of the Supreme Court of Virginia with the Director, Virginia Department of Environmental Quality.

It is the responsibility of the owner and/or operator to ensure that the project is constructed in accordance with the approved Plans and accompanying specifications. Upon completion of the project, the owner and/or operator will be required to submit construction record drawings for all permanent stormwater management facilities (i.e., post-development best management practices) constructed in accordance with the approved Plans.
