It is the responsibility of the owner and/or operator to ensure that the project is constructed in accordance with the approved Plans and accompanying specifications. Upon completion of the project, the owner and/or operator will be required to submit construction record drawings for all permanent stormwater management facilities (i.e., postdevelopment best management practices) constructed in accordance with the approved Plans.
