Dear Ms. Neylon:

We have received for review the report referenced above prepared by New South Associates, Inc. We have also received and approved the necessary archival survey materials. The addendum architectural survey revisits properties that were not accessible to the consultant during the initial survey of Pittsylvania and Franklin counties in 2015. We provide the following comments, which supplement previous comments, as assistance to the Federal Energy Regulatory Commission in meeting its responsibilities under Section 106.

The supplemental survey recorded 34 architectural resources within the study area, with six (6) of the properties being previously documented and 28 being newly inventoried. Of these, 15 are located in Pittsylvania County and 19 are in Franklin County. The consultant recommends and DHR concurs that the following four (4) resources are potentially eligible for listing in the National Register of Historic Places (NRHP): Flora Farmstead (DHR ID #033-0389), House, 7879 Grassy Hill Road (DHR ID #033-5398), House, 1115 Leaning Oak (DHR ID #033-5400), and Oak Grove Christian Church and Cemetery (DHR ID #071-5483). Although VCRIS does not reflect the current status, Flora Farmstead (aka Floradale Farm; DHR ID #033-0389) has already been determined NRHP-eligible by DHR's National Register Evaluation Committee (April 21, 2016) and State Review Board (June 16, 2016). The remaining potentially eligible resources should be fully evaluated for NRHP listing.

The consultant recommends and DHR concurs that the remaining 30 properties are not eligible for listing in the NRHP and do not require additional study: DHR ID #s 033-0388, 033-5183, 033-5376, 033-5377, 033-5378, 033-5380, 033-5382, 033-5383, 033-5384, 033-5386, 033-5388, 033-5389, 033-5390, 033-5391, 033-5395, 033-5399, 071-5157, 071-5465, 071-5506, 071-5507, 071-5508, 071-5515, 071-5516, 071-5517, 071-5518, 071-5519, 071-5520, 071-5521, 071-5522, and 071-5524.


