Dear Ms. Pierce:

On behalf of Mountain Valley Pipeline, LLC (MVP), a joint venture between affiliates of EQT Corporation, NextEra Energy, Inc., Con Edison Gas Midstream, LLC, WGL Holdings, Inc., and RGC Midstream LLC, you will find enclosed two copies of the subject report.

The enclosed document is a second revision of the January 2018 version of this report (first revised in March 2018) that has already been reviewed by West Virginia Division of Cultural and History (WVDCH). In a letter to the Federal Energy Regulatory Commission (FERC) dated February 12, 2018, WVDCH indicated that it concurred with the archaeological Phase I survey recommendations and no further archaeological work is necessary.

In the letter to the FERC dated February 12, 2018, WVDCH also indicated that it could not adequately evaluate the potential eligibility of the barn identified in the January 2018 report without its context within and relationship to the surrounding farmstead and requested that a revised report and complete HPI form addressing the larger property be submitted. Subsequently, Tetra Tech submitted a March 2018 version of the report that included a HPI form for the entire Huffman Farmstead (ME-0389). The revised report recommended that the barn serves as a contributing element to the farmstead, which is recommended eligible for listing in the National Register of Historic Places under Criteria A and C, and as such, project related impacts to the resource should be avoided.

As agreed upon by WVDCH and MVP in emails dated April 26, 2018, and May 10, 2018, the enclosed third version of the report has been revised to document MVP's consultation with WVDCH regarding the avoidance plan, results of the pre-construction survey, communication with the landowner, and MVP's commitments for the Huffman Farmstead (ME-0389) barn that occurred after the March 2018 version (first revision) of the report. No changes have been made to the archaeology sections of this report that already received WVDCH concurrence on February 12, 2018.

Please review this report under Stipulation IV.A. in the executed Programmatic Agreement for the project. This report will also be filed with the Federal Energy Regulatory Commission, lead federal agency for the project. Per Stipulation IV.E., comments should be submitted to Paul Friedman at the FERC.
