To follow up on our telephone conversation on September 15, 2017, please find enclosed for your reference a DVD containing electronic copies of historic architecture reports and corresponding Virginia Department of Historic Resources (DHR) review letters related to Roanoke County. Some of these reports contain information pertinent only to Roanoke County, while others are combined reports covering multiple counties. For your convenience, I have also enclosed a table referencing the pages of those combined reports related specifically to Roanoke County. The DVD contains the technical reports and review letters listed below. I believe this list represents a comprehensive response to your request for documents relevant to the county, but please note that all documents associated with the Section 106 review are available publicly on the FERC docket (CP16-10) should you wish to review additional information.


- *Mountain Valley Pipeline Project, Historic Property Treatment Plan: Bent Mountain Rural Historic District (080-0322) and Coles-Terry Rural Historic District (080-5689) (August 2017) (county review and comment requested)*

I wish to specifically call your attention to the Treatment Plan cited in the in the last bullet. Following submittal of the *Mountain Valley Pipeline Project, Criteria of Effects Report for Virginia* (May 2017), VDHR issued its opinion in a letter dated July 7, 2017, that the proposed Mountain Valley Pipeline Project will adversely affect the National Register of Historic Places-eligible Bent Mountain Rural and Coles-Terry Rural Historic Districts. The Federal Energy Regulatory Commission is consulting with the VDHR on the treatment of historic properties that will be adversely impacted by the proposed project. The enclosed Treatment Plan has been developed to document Mountain Valley's efforts to coordinate with consulting parties and other stakeholders to identify mitigation measures appropriate to address the adverse effect to the Bent Mountain Rural and Coles-Terry Rural Historic Districts identified by VDHR. This Treatment Plan also proposes mitigation measures designed to mitigate the adverse effects of the project.

Mountain Valley looks forward to further discussing the enclosed Treatment Plan and receiving any comments and strategies you might recommend for mitigating the project's adverse effects to the aforementioned districts.
