Dear Ms. Neylon:

The Virginia Department of Historic Resources (DHR) received for review the report referenced above, dated April 2017, prepared by New South Associates, Inc. The document records 40 architectural properties located within the direct Area of Potential Effects (APE) of the Mountain Valley Pipeline project which were documented by the archaeological team. That field documentation was presented to the New South Associates architectural historians so that the properties could be evaluated for National Register of Historic Places (NRHP) eligibility. We provide the following comments as assistance to the Federal Energy Regulatory Commission (FERC) in meeting its responsibilities under Section 106 of the National Historic Preservation Act.

Of the 40 architectural properties inventoried and evaluated in the subject document, the consultant recommends 30 as neither individually eligible for listing in the NRHP nor contributing to a known NRHP-eligible/listed historic district. We concur with these recommendations. The consultant further recommends, and DHR concurs, that the remaining 10 properties are not individually eligible for listing in the NRHP; however, they do contribute to a listed or eligible historic district. Please see the attached table for property-specific recommendations.

While reviewing the report and supporting survey documentation DHR noticed several errors and discrepancies that New South Associates will need to correct. These errors and discrepancies are as follow:

- The page numbers in the report's Table of Contents are incorrect in many instances.
- 060-0332: The V-CRIS form gives the construction date as c. 1850, but Table 1 in the report has it as c. 1940
- 060-5191: The V-CRIS form gives the construction date as c. 1900, but Table 1 in the report has it as "Unknown"



- 060-5193: The V-CRIS form gives the construction date as c. 1900, but Table 1 in the report has it as “Unknown”; also, the V-CRIS form describes the property as “House”, while Table 1 has it as “Farm”
- 060-5195: The V-CRIS form describes the property as “Barn Ruin”, while Table 1 has it as “House and Sheds”
- 022-5040: The V-CRIS form gives the construction date as c. 1900, but Table 1 in the report has it as “Unknown”
- 035-0412-0052: The V-CRIS form gives the construction date as c. 1940, but Table 1 in the report has it as c. 1921
- 035-5093: The V-CRIS form gives the construction date as c. 1950, but Table 1 in the report has it as c. 1930
- 035-5129: The V-CRIS form gives the construction date as c. 1900, but Table 1 in the report has it as “Unknown”
